- ☐ Current payslip

- ☐ Living expenses (food, entertainment, clothing, transport, education, health insurance, medical fees)
- ☐ Personal expenses (sports, hobbies, subscriptions, other insurances, additional super contributions)
- ☐ Credit card debt
